One (1) 20 amp electrical outlet will be provided. PLEASE KNOW YOUR REQUIREMENTS. Additional 20 amp circuits are available at \$25 per circuit. These are Limited to availability and you should inform us of your needs at least 2 weeks prior to the event. If you choose to operate a generator it will have to be pre-approved pending noise output level. All cords and connections to power source are the vendor's responsibility. It is recommended that you have at least 1 – 50ft 12 gauge cord. If UP Hog Wild must provide cords, there will be a \$100 deposit per cord.

Please note the following: The number and type of vendors is limited and is at the discretion of UP Hog Wild 2011. There are NO cash sales. Violators will be asked to close down and cease operation. All sales are made by acceptance of UP Hog Wild 2011 \$.50 tickets.

There is a \$100 Vendor Space Fee DEPOSIT. If you are a competing BBQ Team your Vendor Fee is included in your Contestant Fee. \$25 of Deposit is a space fee. ALL vendors will receive an 80% split of their gross ticket sales. 20% of gross ticket sales will be a donation to UP Hog Wild 2011. \$75 of Deposit will be returned after the gross sales donation meets the \$75 minimum. Vendors should be able to sell from 5:00 PM to 12:00 AM Friday July 15th and from 12:00 PM to 12:00 AM Saturday July 16th.

This license must also be prominently on display during sales hours. An INSURANCE RIDER naming the City of Kingsford and UP Hog Wild, Inc must be provided prior to your final acceptance as a vendor.

Please read the following and sign below. These items are a requirement as part of the Temporary Liquor License held by UP Hog Wild, Inc, and granted by the Michigan Liquor Control Commission.

This agreement between UP Hog Wild, Inc. and the "Vendor" will run from signing through the event "UP Hog Wild 2011" which will be open to the public during the hours of 5:00PM Friday July 15th, to 1:00 AM Saturday July 16th, and 11:00 AM July 16th to 1:00 AM Sunday July 17th.

UP Hog Wild, Inc's Two Day Temporary Liquor License will cover the sale of controlled alcoholic beverages from 5:00 PM on Friday July 15th through 11:59 PM on Saturday July 16th, and shall be bound by all operating regulations attached to such license.

UP Hog Wild, Inc. will receive all profits from the sale of alcoholic beverages.

UP Hog Wild, Inc. will maintain control and responsibility for the actions of all persons or employees operating the concession business as they relate to the Liquor Control Act and Rules or violations of the Act and Rules.

UP Hog Wild, Inc. will retain control over all portions of the licensed premises.

UP Hog Wild, Inc. shall purchase all alcoholic beverages from an authorized source.

UP Hog Wild, Inc. is granting the vendor (concessionaire) the right to use the facilities and are not leasing or renting any portion of the premises.

Waiver of Liability: In consideration of your accepting this entry, I the undersigned, intending to be legally bound, hereby, for myself, my heirs, executors and administrators, waive and release any and all rights and claims for damages including any claims based on alleged negligence, that I have or may have against UP Hog Wild, Inc, UP Hog Wild 2011, The City of Kingsford, their representatives, successors, and assigns for any and all injuries suffered by me at UP Hog Wild 2011. Notes and Reminders to Vendors for UP Hog Wild 2011

1. Vendors and staff will be required to wear event bracelets.
2. Six (6) bracelets will be provided at NO Charge to Commercial Vendors.
3. Twelve (12) bracelets will be provided at NO Charge to Non-Profits.
4. Additional bracelets will be sold to Vendors at \$5.00 each.
5. A copy of your food licenses must be provided to UP Hog Wild one week PRIOR to the date of the event. July 8, 2011.
6. A copy of your liability insurance / vendor insurance MUST be presented to UP Hog Wild one week PRIOR to the date of the event. July 8, 2011
7. Vehicles will not be permitted beyond the WEST parking area once the event gates are open to the public. There will be NO vehicular traffic inside the public portion of the event grounds while the public is in attendance.
8. NO CASH SALES WILL BE ALLOWED OR ACCEPTABLE TO THE PUBLIC. Violators will be asked to close their booth and they will be banned from further participation at UP Hog Wild. Coupon / Ticket sales ONLY.
9. Please police your area and keep it clean so that this is a safe, enjoyable and pleasant experience for our customers and guests.
10. It is helpful to accountants and auditors if your tickets are banded or bundled by like size ticket strips. The easier it is for you to count the tickets, the easier it is for us to re-count them.
